

NPU-T Meeting Minutes  
Wednesday, May 14, 2008

The General meeting was called to order at 7:34 pm EST by Chairman Kwabena Nkromo

**1) Invocation**

The invocation was presented by Cardinal Brown from the Shrine of the Black Madonna.

**2) Approval of Agenda –**

A motion was made by Jerry ‘Tacuma’ Brown to accept the agenda as modified with this seconded by Jasper Boykin. The modification was to remove item #13 which has been withdrawn from consideration.

Vote: Yes- 7; No - ; Abstain-0 → Motion Carries

**3) Approval of Minutes – April**

a) Copies of the April Minutes were distributed for approval.

A motion was made by Oni Holley to approve the minutes as published. This was seconded by Jerry ‘Tacuma’ Brown.

Vote: Yes- 10; No-0; Abstain- 1 → Motion Carries

**4) Police, Fire, and Community Prosecutor’s Updates (5 minutes per report)**

**a) Police**

(1) Major Dallas (Zone 1) spoke.

- (a) Major Dallas highlighted the activities of beat 103. He indicated that of the 24 recent graduates from the Police Academy, 12 were added to Zone 1 and 12 to Zone 4.
- (b) Major Dallas further described recent crime reduction activities within Zone 1.
- (c) Copies of the crime stats were left with the NPU-T chair.

(2) Lt. Chris Leighty (Zone 4) spoke.

- (a) Lt. Leighty spoke about the new foot patrols that were added to Zone 4.
- (b) He indicated that crime overall is down 9% year-to-year.
- (c) Jerry ‘Tacuma’ Brown asked that at a subsequent meeting, the Quality of Life Officer be invited to the NPU-T meetings to discuss the roles that he plays within the Zone.
- (d) Lt. Leighty spoke about a recent attempted burglary that took place. The suspect was a City of Atlanta employee. After an agreed-upon search, there was over a kilogram of Cocaine, \$50,000 in cash and various weapons confiscated.

**b) Fire –**

(1) Captain Perdue of Station #17 spoke.

- (a) He highlighted that there have been no layoffs in NPU-T fire stations.
- (b) He also highlighted the increase of fires in vacant or abandoned houses and asked that if anyone is seen occupying a vacant residence, they contact both the police and housing code enforcement.

**c) Community Prosecutor – Ms. Blackett-Jones (Zone 4) spoke. 404.699.5294**

- (1) Ms. Blackett-Jones highlighted several recent court cases.
- (2) She highlighted the recent attempted burglary on West Ontario.
- (3) Ms. Blackett-Jones has asked for help with addressing issues of 40 men that have been identified as candidates for a pilot diversion program. The District Attorney’s office is creating a “Citizen’s Council” to support this program. Another facet of this program is to create a mentor program.

**d) Department of Watershed Management - Veltricia McMichael –**

5) Presentations

- a) **Dean Rusk YMCA Head Start Early Learning Academy** – Kara Portnell, Early Learning Property Management
  - i) The applicant spoke about their plans for the subject property.
    - (1) There are 350,000 s.f. available for the Head Start Program which will be targeted towards 350 children.
    - (2) The modifications of the property will be interior only, with the exception of additional windows and the establishment of additional parking spaces.
    - (3) Storm water management, fire sprinkler systems and landscaping will be added to the property as part of the redevelopment actions.

    - (1) Ms. Kathy Augustine spoke about key activities being undertaken by APS in support of their Community Affairs. The principals from Brown Middle School and Washington High Schools were present. Several other members of APS were present, including Khatiim S. El.
      - (a) Ms. Augustine highlighted several key successes within the system. A handout with these highlights was distributed to attendees at the NPU-T meeting.

### **Urban Agriculture Subcommittee – Kwabena Nkromo, [kwabena.nkromo@gmail.com](mailto:kwabena.nkromo@gmail.com)**

*The mission of the Urban Agriculture Subcommittee is to promote, support and develop food production activities of all types within NPU-T to further the goals of our Community Food Project.*

- The Urban Agriculture Subcommittee has accomplished the following results related to the two immediate focus areas of the NPU-T Community Food Project (CFP):
  - Supporting our existing urban agriculture activities within NPU-T (particularly community gardens)  
We have continued to organize an event to bring NPU-T community gardeners together, although we have renamed it the "NPU-T Community Gardens Summer Summit" due to the passing of spring. The venue will no longer be at the Atlanta Community Food Bank, but rather a site fully within NPU-T due to the increasing amount of activity now occurring in response to the CFP initiative. Likely candidates for the location of the Summit are the Good Shepherd Community Church in the West End or the CVC Urban Farm in the Beecher-

Donnelly area. Existing community gardens within NPU-T that will be invited include Ashview Heights, Mother Clyde, and Rose Circle. The date is tentatively July 12th 2008.

- Identifying potential sites for urban farms within NPU-T and recruiting growers to develop them in order to establish "backbone" supply for a farmers market/cooperative

There are three new "farm" sized urban agriculture projects that we are supporting through the CFP. (1) CVC Urban Farms is a collaboration between Creating Vibrant Communities Inc (a local non-profit) and the Pan African Orthodox Christian Church (Shrine of the Black Madonna), with NPU-T providing coordination and other supports. The other key partner is Rashid Nuri with Truly Living Well Natural Urban Farms who is serving as lead consultant on the project. The primary goal of CVC Urban Farms is to demonstrate asset based community development through contributing to the creation of a local food economy in the West End. The non-profit farm will grow fresh vegetables and fruits to sell at below market rates through CSA shares targeted at NPU-T residents and a local farmers market. (2) The Good Shepherd Community Church, under the leadership of Rev. Richard Bright, has a vision of creating a "ministry garden" on land owned by the church at the corner of Lawton and Lucille in the West End. NPU-T has engaged Good Shepherd through the CFP to connect this vision to our goal of a network of various urban agriculture uses in the neighborhoods. We are designing a "mixed use" site plan with the church that includes the developing ministry garden, a membership community garden for neighboring residents, and a second CVC Urban Farms site, and "Plant a Row for Hunger" plot for the Atlanta Community Food Bank. With approximately 3 acres available, this project promises to be an outstanding example of possibilities of the CFP. (3) NPU-T currently has a proposal before the Atlanta Public School to develop a mixed use urban agriculture project on APS owned land adjacent to the campus, which would include (i) an "edible schoolyard" outdoor classroom for the students (ii) a multi-accessible community garden (iii) and a third CVC Urban Farms site. Having gained the support of the school principal (Mr. Underdue), we are awaiting a response from senior APS management.

- Our mid-range goals include:
  - Completing an asset map of all available land within NPU-T that could potentially be used for urban agriculture and grade each site for recommended type of use (i.e. community garden, urban farm, etc). We have engaged Morehouse College regarding partnering with their GIS program to create the asset map described above. It was suggested that funding will be necessary to activate this opportunity, but a final determination has not been made. We are also exploring other GIS resource options.
  - Developing educational and training opportunities for residents interested in learning about urban agriculture or increasing their existing skills. We have engaged Georgia Organics regarding partnering to conduct educational workshops on urban agriculture for residents and stakeholders within NPU-T. This activity will be managed by a newly created urban agriculture subcommittee of the NPU-T Education Committee
  - identifying resources (tools, funding, etc) to assist growers within NPU-T to be productive and successful. We have connected residents and urban agriculture projects within NPU-T to each of the following resources: The Atlanta Community Food Bank Community Gardening Program, Georgia Organics, The Atlanta Community Tool Bank, Khari Diop (site design expert), and Truly Living Well Natural Urban Farm (food production consultant).
- There were no formal meetings during the previous period, but an Urban Agriculture Subcommittee meeting of the PRCA Committee will be scheduled for late May or early June.
